**age groups:**

U14	2010 and 2011
U17	2007, 2008 and 2009

**weight classes:**

U14	31, 34, 38, 42, 46, 50, 54, 58, 62, 66 and 73kg (with no tolerance)
U17	40, 43, 46, 49, 53, 57, 61, 65, 69 and 73kg (with no tolerance)

**eligibility:**

All wrestlers must present a valid competition license with the current year's control stamp to the officials during the weigh-in. If no valid competition license is provided, the wrestler will be denied participation and is not allowed to compete. A start with a child's passport, travel document, or any other identification is not permitted. This rule also applies to foreign competitors without a valid competition license from their home country, participation is not allowed.

**Weigh-in // start of competition:**

8.00 – 9.00 h // 10:00 h

**registration for the tournament:**

Please register by October 24, 2024, per club and with a list of names using the registration form "Meldeliste IFT 2024" and send it to [ausschreibung@luftfahrt-ringen.de](mailto:ausschreibung@luftfahrt-ringen.de). Registration is to be done exclusively in digital form by the clubs. The number of participants must be limited to a maximum of 150.

**referee:**

Each club/association with 5 or more participants has to provide a judge or pay a fee of 100 €. Each referee receives 35 € compensation. Please register referees by name.

**Entry fee:**

U14 – 20,00 € per wrestler // registration after October 24, 2024: 40,00 € per wrestler

U17 – 25,00 € per wrestler // registration after October 24, 2024: 50,00 € per wrestler
